II Award for the Presentation of "The Best Masonic Paper"

Rules

1. The papers presented must never have been published previously in any form and can be articles, essays, thoughts (all in Spanish) which have close dealings with the reality of Freemasonry from a historical, contemporary, symbolic, ritualistic, fraternal or purely existential point of view.
2. All active members of The Grand Lodge of Spain are eligible to participate using the established criteria. Each brother can only present one paper.
3. The papers will be sent in by e-mail, A4 format, double line spacing and should have a minimum length of one page and a maximum of three pages. Each paper must be signed by the writer who must state his name, surname(s), the name of the lodge which he is a member of, his address, age, telephone number(s) and e-mail address. Any brother who chooses to use a pen-name should state the lodge which he is a member of and should attach a letter from the secretary of his lodge, giving documentary proof (without mentioning the name of the brother concerned) that the brother using the pseudonym is a member of the lodge.

The paper presented will remain the property of the Grand Lodge of Spain for subsequent publication in the Grand Lodge of Spain magazine "LATOMIA".

4. The closing date is the 25th. February 2012 at 20.00. All papers should be sent to premioplanchamasonica@gmail.com with the reference : The Second Award for the "Presentation of The Best Masonic Paper".
5. Only one prize will be awarded: the winning paper will be presented (read out) at the Grand Lodge of Spain AGM on 10th. March 2012.
6. The panel of judges will be made up of The M.W. Grand Master of The Grand Lodge of Spain and a number of representatives of Grand Lodge who have been appointed and whose decisions will be final. The judges' decision will be announced in the private area of our Website: www.gle.org and communicated to each lodge.
7. The winner must personally attend the presentation ceremony when the award will be presented by M.W. Bro. Oscar de Alfonso Ortega.
8. Participation in this event constitutes acceptance of its conditions and rules.
